A folio of notarized deed with a final fragment of a deed submitted before the notary of Cajatambo, Emilio Bustamante, followed by another, numbered 46, of the lease of mojonazgo (tax) granted by the Provincial Council of Cajatambo in favor of Pedro Altes (02/05/1896). It has the original page numbering "twenty and five" in the upper central part, and revenue stamps, sixth in obverse and fourth in reverse. It shows a regular state of conservation, with traces of unsewn. It is an original document (neither copy nor testimony) signed by grantors and notary, in italic handwriting.

It has a regular state of conservation, with traces of unsewn. It is an original document (neither copy nor testimony) in italic handwriting.

A fragment of a notarized deed of agreement between Francisco Minaya, in the name of his wife Paula Fuentes Rivera, and Esteban Soto, to finalize the nullity trial of the estate of Pascuala Fuentes Rivera, submitted to Judge Romualdo Barreto de Cajatambo. The seal of the paper covers the years 1893-1894. The document has the alphabetical page numbering "nine" in the upper central part and 18 revenue stamps on the obverse. It has a regular state of conservation, with traces of unsewn. It is an original document (neither copy nor testimony) in italic handwriting.
