In the first one, Petronila Sena sold a black female slave named Mónica to Juana González; document signed in Lima on [15] May 1832. Below, sale of a female slave (hunted directly or bought from intermediaries in their places of origin) named Mariana, made by Teresa de Aguilar, wife of Manuel Castro, to Juan Rondón; the slave had been purchased from Ramón Pateondo; document signed in Lima, 16 May 1832. In the back page, there is shown a power of attorney granted by Manuel Hidalgo and Juana Vives to Benito Suáres, prosecutor of the Superior Court of Justice, before Gaspar Jurado (05/17/1832). Next, Sister María del Carmen (illegible) appears giving a receipt for an amount of pesos of the census results; before Baltasar Núñez del Prado (05/18/1832).






Image: Front View




Image: Rear View

Another inscription of the sale of the female slave Tomasa, who had previously belonged to Melchora Molina, sale made by Rafael Valdiviezo to Rafaela Flores, wife of Pablo Blanco; signed in Lima, on 2 June 1832. Sale of the black female slave Bacilia, who had been bought from Josefa Salguero, by Rosa Espinosa to Pablo Chávez; in Lima, 2 June 1832.








Image: Rear View






Image: Front View




Image: Rear View






Image: Rear View






Image: Front View




Image: Rear View






Image: Front View




Image: Rear View

The document also contains incomplete deed granted in favor of Mariano Espinoza on 05/07/1833, and then another of power of attorney granted by Manuel Gonzáles to José Echevarria, on the same day 05/07/1833; both deeds before Gaspar Jurado, scribe.






Image: Rear View

Later, another deed records the sale of a black female slave named Dolores, who had previously been the property of Lorenza Piñeiro, sold by Maria Camborda to Antonio Sacio; signed in Lima, 7 June 1833. The document also contains a power of attorney granted by Manuel Arriaga, prior of the Convent of San Agustín, before Gaspar Jurado, on 05/20/1833. Finally, an incomplete deed granted by Francisco Llamamanse and José de los Santos Acuña, natives of Coayllo, giving their power of attorney fulfilled.






Image: Rear View








Image: Rear View
