At the lower part of the left side, there is a paper frame adhered as a patch, which is repeated on the opposite side of the folio. The backside shows migration of iron-Galic ink (manuscript and autograph), oxidation of ink (autograph), and yellow stains due to humidity; the edges of the support have irregularities due to loss, breakage and lack of support.




Image: Front View, Top Detail




Image: Front View, Central Detail


